

ORDINANCE NO. FY2022-002

**ORDINANCE PROVIDING FOR AMBULANCE SERVICES USER FEES
OF THE RUTLAND DUNDEE TOWNSHIPS FIRE PROTECTION DISTRICT
KANE COUNTY, ILLINOIS**

WHEREAS, the Rutland Dundee Townships Fire Protection District (the "District"), is a fire protection district duly organized under the laws of the State of Illinois; and

WHEREAS, the Board of Trustees of the District has full power to pass all necessary ordinances, and rules and regulations for the proper management and conduct of the business of the Board of Trustees of the District for carrying into effect the objects for which the District was formed under 70 ILCS 705/6; and

WHEREAS, the District provides ambulance services to residents and non-residents of the District at a cost to the District that is not fully covered by the District's tax revenues; and

WHEREAS, it is necessary in order to continue to provide quality ambulance and emergency medical services to establish fees to be charged to recipients of such services; and

WHEREAS, the Board of Trustees of the District has the authority, pursuant to 70 ILCS 705/22(d)(4) to fix, charge, and collect fees for emergency ambulance services within or outside the District not exceeding the reasonable cost of said services; and

WHEREAS, the District has determined the reasonable cost of its ambulance services; and

WHEREAS, the District has determined that it is reasonable to charge non-residents a portion of the District's cost of providing said services; and

WHEREAS, the District has determined that because residents of the District support the operation of the District through taxation, it is reasonable to charge residents of the District for the use of such services at a rate that is less than that charged to non-residents of the District;

NOW, THEREFORE, BE IT ORDAINED by the Board of Trustees of the Rutland Dundee Townships Fire Protection District, Kane County, Illinois, as follows:

Section One: The Board of Trustees hereby assigns the following ambulance fee schedule for Non-District residents, which said fees do not equal or exceed the cost of providing the services set forth:

Non-District Residents

BLS Emergency w/ Transport	\$ 1,450.00
ALS 1 Emergency w/ Transport	\$ 1,850.00
ALS 2 Emergency w/ Transport	\$ 2,300.00
ALS Emergency Non-Transport	\$ 400.00
Extrication	\$ 300.00
Extra Attendants required for patient care or movement (per attendant)	\$ 75.00
Mileage (per mile fee)	\$ 16.00

Section Two: The Board of Trustees hereby assigns the following ambulance fee schedule for District residents, which said fees do not equal or exceed the cost of providing the services set forth:

District Residents

BLS Emergency w/ Transport	\$ 1,050.00
ALS 1 Emergency w/ Transport	\$ 1,375.00
ALS 2 Emergency w/ Transport	\$ 1,575.00
ALS Emergency Non-Transport	\$ 400.00
Extrication	\$ 300.00
Extra Attendants required for patient care or movement (per attendant)	\$ 75.00
Mileage (per mile fee)	\$ 16.00

Section Three: All revenue from the charges assessed pursuant to this Ordinance shall be deposited in the General Operating Funds of the Rutland Dundee Townships Fire Protection District.

Section Four: The Fire Chief may, in his discretion, waive the costs and/or fees due under this Ordinance in whole or in part.

Section Five: Nothing in this Ordinance shall authorize the District to refuse to provide any service to any person, business or entity that has not paid for services previously provided or that owes any money for services previously provided.

Section Six: This Ordinance shall be published or posted in compliance with 70 ILCS 765/7 within 30 days of its passage.

Section Seven: The provisions of this Ordinance shall be in full force and effect ten days following the publication or posting thereof.

Section Eight: This Ordinance shall supersede any ordinances, resolutions or motions or parts of ordinances, resolutions or motions in conflict with any part herein, and any such ordinances, resolutions, or motions or parts of such are hereby repealed to the extent of any conflict.

Section Nine: If any section, paragraph or provision of this Ordinance shall be held invalid or unenforceable for any reason, such invalidity or unenforceability shall not affect any of the remaining provisions of this Ordinance.


